The Department of Child Support Services (DCSS) has finished an audit of your support account(s). In doing this audit, the DCSS applied all the support payments made by SLADE DANIEL SMILEY or by the employer on his or her behalf to the support payments that are owed to you. For any month that the support payments were late or not paid, interest was added to the account(s).

The California Code of Civil Procedure (CCP), Section 685.010, states if court ordered payments are not paid, then 10 percent interest is added to the total unpaid amount. Also, CCP, Section 658.020, states that if the court ordered payments are to be made in installments, then 10 percent interest is added to the missed installment payment amount on the day it becomes late.

Generally, support payments are first applied to the support that is owed for the month that the support payment was received by DCSS. If any money is left over, it is used to pay any past due support owed. Payments received prior to January 1, 2009, were used to pay accrued interest first, then the principal balance. Per Assembly Bill 2669, payments received as of January 1, 2009 will be used to pay the principal balance first, then accrued interest (CCP Section 695.221).

As of 10/08/2009 our records show that you are owed \$71339.61 in late support payments, and you are owed \$6017.14 in interest which equals a total of \$77356.75 that is owed to you.

# AN OBLIGOR MUST BE IN COMPLIANCE WITH THE JUDGMENT OR ORDER FOR SUPPORT BEFORE THE OBLIGOR'S DRIVER'S LICENSE CAN BE RELEASED BY THE CHILD SUPPORT SERVICES DEPARTMENT

California <u>Family Code</u> Section 17520 states that "except as otherwise provided in this section, the local child support agency shall not issue a release if the applicant is not in compliance with the judgment or order for support."

<u>Family Code</u> Section 17520 (k) (1)(2)(3) and (4) provide that Judicial review of the local child support agency's decision in matters regarding licenses shall be limited to a determination of only four issues:

- (1) Whether there is a support judgment, order or payment schedule on arrears or reimbursement,
- (2) Whether the petitioner is the obligor covered by the support judgment or order, and
- (3) Whether the support obligor is or is not in compliance with the judgment or order of support, and
- (4) The extent to which the needs of the obligor, taking into account the obligor's payment history and current circumstances of both the obligor and the obligee, warrant a conditional history as described in this subdivision.

A driver's license is a privilege, not a right, and as such is subject to regulation including suspension for failure to pay child support at the discretion of the Legislature. See Roger Sunpath Tolces v. Grover Trask, 76 Cal. App. 4th 285 (1999). The Respondent owes \$71,339.61 in principal and \$6,623.04 in interest. The Respondent owes substantial arrears in this case due to his failure to make consistent payments over the course of the child support order. He has not made a payment on this case in over a year. See Exhibit 2. If the court decides to release the driver's license, we request that the Respondent be ordered to make a lump sum payment prior to the release of the driver's license and comply with a reasonable repayment plan.

#### MODIFICATION OF SUPPORT

The Child Support Services Department requests that the court adhere to the statewide uniform guidelines as set forth in <u>Family Code</u> Section 4050 et sec. Accordingly, the current child support order should remain in full force and effect or be increased if appropriate pursuant to guidelines. The Respondent has presented this court with no evidence that the application of said guidelines would be inappropriate or unjust in this case. Further, no special circumstances exist which warrant a deviation from the guideline amount.

Additionally, the Child Support Services Department requests that the court in accordance with <u>Family Code</u> 4058 (b), take the earning capacity of Respondent into account and weigh this ability to earn, in deciding the child support amount, as it relates to the best interest of the minor child, Grayson Arroyo-Smiley. The court requires that there be a change in circumstances to justify a change in a support order, <u>In Re Marriage of Popenhager</u>, 99 Cal. App 3d 514, 521 (1979). Absent such a change in circumstances, the Respondent's motion should be denied.

#### STAY ARREARS ENFORCEMENT

The Respondent has provided no legal or factual basis to stay arrears enforcement. The Child Support Services Department's Records indicate that the Respondent currently owes \$71,339.61 in principal and \$6,623.04 in interest on child support arrears in this case. See Exhibit 1. Until the arrears are paid in full, the Child Support Services Department has the right to enforce this case, Green v. Cutler, 79 Cal. App. 4th (2000). As such, the Respondent's request to stay arrears enforcement should be denied.
